## NEW ZEALAND WINEGROWERS VISIT THE VINES SCAN AND WIN 2020 GIVEAWAY TERMS AND CONDITIONS

1. Details of the Visit the Vines Scan and Win 2020 Promotion (**Promotion**), including promotional text, form part of these Terms and Conditions (**Conditions**).
2. Participation in this Promotion is deemed acceptance of these Conditions.
3. The Promotion commences at 09:00am on Friday, 4 December 2020 and closes at 11:59pm on 31 January 2021. No entries beyond this time will be accepted.
4. The organiser of this Promotion is New Zealand Winegrowers Incorporated (**NZW**), Level 4, 5-7 Kingdon Street, Newmarket, Auckland 1010, New Zealand.
5. Participating Wineries and Vineyards are those organisations who have registered with NZW and displaying a valid Visit the Vines Scan and Win 2020 Promotion QR Code.
6. Entry is open to New Zealand residents aged 18 years and over only. NZW, Participating Wineries and Vineyards and their employees and their immediate families are ineligible to enter.
7. NZW reserves the right to verify the validity of entries.
8. Multiple entries per person are permitted as long as each entry is made on a separate visit to a Participating Winery or Vineyard.
9. Each entry requires the participant to visit one of the Participating Wineries or Vineyards, scan the Visit the Vines Scan and Win 2020 Promotion QR code and complete and submit their details in an online entry form.
10. The Winner of the Promotion will receive return economy flights on Air New Zealand for 2 adults ex one of 20 NZ regional airports to a NZ wine region (Kerikeri, Auckland, Gisborne, Napier, Wellington, Blenheim, Nelson, Christchurch, Queenstown or Dunedin) and 2 nights 4-star accommodation - in either Northland, Auckland (Waiheke, Matakana, West Auckland) Gisborne, Hawke's Bay, Wairarapa, Marlborough, Nelson, North Canterbury, Central Otago (Gibbston, Cromwell or Alexandra) or Oamaru (**the Prize**). NZW reserves the right to substitute the Prize in whole or any of its components with a substitute prize of equal or greater value.
11. Where the Prize includes air travel and/or accommodation:
  - a. All Travel and accommodation must be redeemed by 15 December 2021.
