| <b>GREEN</b>  | Can operate*  | <b>WITH VACCINE CERTIFICATES:</b><br>No limits for hospitality and events.  | <b>WITHOUT VACCINE CERTIFICATES:</b><br>Max of 100 people for hospitality, with 1m distancing, seated and separated<br><i>[similar to Alert Level 2]</i>                                  |
| <b>ORANGE</b>   | <b>Face masks mandatory in more places, including retail, public transport.</b>   |   |   |
|   | Can operate*  | Retail can open, with capacity limits based on 1m distancing.<br><br><b>WITH VACCINE CERTIFICATES:</b><br>No limits for hospitality, gatherings and events.   | <b>WITHOUT VACCINE CERTIFICATES:</b><br>Hospitality must be contactless only (eg click and collect/takeaway). Events cannot proceed (regardless of whether they are indoors or outdoors). |
| <b>RED</b><br><br><b>Three Phases of Omicron Response</b><br>The Government's phased response relates to the management of confirmed cases, close contacts, isolation requirements and testing.<br>We are now in <b>Phase 3</b><br>Details are available <a href="#">here</a> | <b>Face masks are mandatory at more places including public transport, retail, hospitality businesses, events, gatherings and other close proximity businesses except when seated, eating, drinking or exercising. Masks are not required for attendees at gatherings where they have exclusive use of the venue (eg weddings). Workers covered by the My Vaccine Pass vaccination mandate in public facing roles and workers who are utilising either of the return-to-work pathways must wear medical grade masks at all times.</b> |   |   |
|   | Can operate*, but working from home is encouraged where possible  | Retail can open, but capacity limits must be set based on 1m distancing.<br><br><b>WITH VACCINE CERTIFICATES:</b><br>Max of 100 people for hospitality, 1m distancing, seated and separated.<br><i>[similar to Alert level 2]</i> | <b>WITHOUT VACCINE CERTIFICATES:</b><br>Hospitality must be contactless only (eg click and collect/takeaway).   |
