Cancellation policy	<p>Where a Participating Winery cancels its participation in the Event, any refund of the Fee, or part thereof, to a Participating Winery who has registered for and paid the Fee, shall be calculated as follows:</p> <ol style="list-style-type: none"> cancellation four weeks or less prior to the Event: no refund; cancellation four to eight weeks prior to the Event: 50% of the Fee will be refunded. <p>If the Fee or part thereof has not been paid prior to the Participating Winery cancelling their participation, the Participating Winery is still responsible for and will be invoiced for cancellation accordingly.</p>											
Additional conditions	<p>All wines entered into this Event must adhere to the NZWG Sustainability Policy which states that wines are eligible to be entered into a NZWG events as long as they are 100% certified by a recognised sustainability programme (SWNZ, BioGro, AsureQuality and Demeter certifications).</p> <p>Please note that there is a maximum capacity for participation in this event, which will be secured on a 'first come, first served' basis. If capacity is reached, there will be a waiting list. If a winery secures participation through the waiting list (which also be on a 'first come, first served' basis), they will be notified by NZW as soon as reasonably possible and will have three working days to confirm participation.</p>
